Subject to the provisions of article 234 paragraph 1, letter 1) of F.S.A Regulation no. 5/2018 *regarding Issuers of Financial Instruments and Market Operations*, S.N.G.N. Romgaz S.A. informs the shareholders and investors that the request for appeal made by the applicant Sindicatul Liber Romgaz Medias was dismissed, according to Sibiu Court Ruling no. 210/cc/May 21, 2019, on grounds of lack of standing to bring proceedings.

The Ruling no. 210/cc/May 21, 2019 remained final, as the applicant Sindicatul Liber Romgaz Medias did not file for appeal within the legally provided term.
