- Coordinating the revision of the two plans if the Commission considers that the measures do not mitigate the risks identified in the risk assessment, are not concordant with risk scenario or with other competent authority plans or threatens the security of gas supply of other member state or of the Union as a whole.
- Identifying the relevant gas enterprises undertaking the measures which ensures gas supply for the protected consumers of member state in accordance with the provisions of Article 8 of Regulation no. 994/2010 on Supply Standard
- Collaborating with the Regulatory Authority for Energy, within its powers
- Coordinating the initiation of the draft legislation in order to harmonize the legislation of security of gas supply with the European Union legislation.
