### REPORT

# on contracts for sector procurement of goods and works of a value higher than EUR 500,000/procurement and of services higher than EUR 100,000/procurement, respectively, concluded during April 1, 2021 - June 30, 2021

In accordance with the provisions of Article 22, letter a) of Board of Directors Resolution No. 22/October 30, 2014, we hereby provide the *Report on contracts related to sector procurement of goods and works of a value higher than EUR 500,000/procurement and of services higher than EUR 100,000/procurement, respectively,* concluded by SNGN Romgaz SA in Q2 2021.

The sector procurement activity was carried out in accordance with the provisions of Law No. 99/2016 on sector procurement and of Government Decision No. 394/2016 approving the Enforcement Guidelines on awarding sector contracts/framework agreements of Law No. 99/2016, with subsequent amendments and supplements.

The procurements complied with S.N.G.N. ROMGAZ S.A. Annual Program of Sector Procurements for 2021 (procurements of goods, works and services), approved by S.N.G.N ROMGAZ S.A. management. Procurements were financed from own financing sources.

In Q2 2021, S.N.G.N. ROMGAZ S.A. awarded sector procurement contracts for goods and works with values higher than EUR 500,000 /procurement and sector procurement contracts for services with values higher than EUR 100,000/procurement, respectively, as summarized below:
