REPORT

on sector-specific contracts for the procurement of goods and works above EUR 500,000 /procurement, and services above EUR 100,000/procurement, concluded during January 1, 2022 – March 31, 2022

In accordance with the provisions of Article 22, item a) of the Board of the Directors Resolution No. 22/October 30, 2014, we hereby submit the *Report on contracts related to sector procurement of goods and works above EUR 500,000/procurement, and of services above EUR 100,000/procurement, respectively,* concluded by SNGN Romgaz SA in Q1 2022.

The sector procurement activity was carried out in accordance with the provisions of Law No. 99/2016 on sector procurement and the Government Decision No. 394/2016 approving the Enforcement Guidelines on awarding sector contracts/framework agreements of Law No. 99/2016, as subsequently amended and supplemented.

The procurements complied with S.N.G.N. ROMGAZ S.A. Annual Program of Sector Procurements for 2022 (procurements of goods, works and services), as approved by S.N.G.N ROMGAZ S.A. management. Procurements were financed from own financing sources.

In Q1 2022, S.N.G.N. ROMGAZ S.A. awarded sector procurement contracts for goods and works above EUR 500,000/procurement and sector procurement contracts for services above EUR 100,000/procurement, respectively, as summarized below:

The acquisition was made through an Open Tender procedure, with an estimated value of RON 3,020,284.00, sourced from investment funds, 2021 Sector Procurement Plan (PAS) position 768,2 Goods, for which the contract award notice No. CAN 1070385/06.01.2022 was published. The Procurement (Tenders) Office headquarters, organized the procurement procedure.
- Contract No. 37282/22.02.2022 concluded with S.C. SUTECH S.R.L. Mediaş, for SC Filitelnic Cameron Gas Compressors Parts 2 Batches, amounting to RON 7,633,630.07, VAT excluded, out of which RON 6,905,747.75 for Batch 1 and RON 727,882.32 for Batch 2, for a period of 12 months after the contract is executed by both parties. The acquisition was made through an Open Tender procedure, with an estimated value of RON 7,634,846.00 out of which: Batch 1- RON 6,906,651.00, Batch 2- RON 728,195.00, sourced from production funds, 2021 Sector Procurement Plan (PAS), Positions P-694.27 and P-694.28 Goods, for which the contract award notice No. CAN 1073746/26.02.2022 was published. The Procurement (Tenders) Office at the headquarters organized the procurement procedure.
- Contract No. 37284/22.02.2022 concluded with S.C. SUTECH S.R.L. The Procurement (Tenders) Office at the headquarters organized the procurement procedure.

production funds, 2022 Sector Procurement Plan position 18.1 – Goods, for which the contract award notice No. CAN 1074514/09.03.2022 was published. The Procurement (Tenders) Office at the headquarters organized the procurement procedure.

Mediaş, for AJAX Gas Compressors Parts - Batch 3-8, amounting to RON 3,162,779.05, VAT excluded, for a period of 12 months after the contract is executed by both parties. The acquisition was made through an Open Tender procedure, with an estimated value of RON 3,179,078.10, sourced from production funds, 2021 Sector Procurement Plan position 694.20 - Goods, for which the contract award notice No. CAN 1075942/31.03.2022 was published. The Procurement (Tenders) Office at the headquarters organized the procurement procedure.

The acquisition was made through an Open Tender procedure, with an estimated value of RON 30,290,566.00, sourced from investment funds, 2021 Sector Procurement Plan PAS – Works – Position L-30.7, for which the contract award notice No. CAN 1074512/09.03.2022 was published. The Procurement (Tenders) Office at the headquarters organized the procurement procedure.
