**SNGN ROMGAZ SA GENERAL MEETING OF SHAREHOLDERS**

**REPORT**

**on certain significant transactions with affiliated parties concluded between SNGN ROMGAZ SA and banks during March 08, 2023 - June 12, 2023**

**Reasons for Reporting**

Pursuant to art. 52 par. (1) of Government Emergency Ordinance No. 109/2011<sup>1</sup> "The Board of Directors [...] convenes the general meeting of shareholders in order to approve any transaction, if its value, individually or in a series of concluded transactions, exceeds 10% of the value of net assets [...] or exceeds 10% of the revenue ... with the controlling shareholders or with a company controlled by such shareholders".

Moreover, pursuant to art. 52 par. (3) of Government Emergency Ordinance No. 109/2011 "The Board of Directors [...] informs the shareholders, during the first general meeting of shareholders following the legal act, on any transaction concluded by the public company with:

- the persons provided in paragraph (1) and (2) and the value of the transaction is below the level established in paragraph (1);
- another public company or with the public supervisory authority, if the transaction has a value, individually or in a series of transactions, of at least the equivalent in RON of EUR 100,000".

Thus, we hereby inform SNGN ROMGAZ SA GENERAL MEETING OF SHAREHOLDERS that, during March 08, 2023 and June 12, 2023, SNGN ROMGAZ SA concluded with banks the following term deposit agreements:
