- The calculation base includes all costs in connection with the gross monthly wages, including relating contributions, and other expenses and costs borne by the Supplier for the performance of activity under normal conditions in accordance with the approved budget and work programs.
- Where no separate determinations can be made, electricity shall be allocated based on readings and proportionate cost allocations depending on the Base Production and Incremental Production recorded at a specific Point.
- Additional costs in connection with gas metering and delivery (gas chromatograph analysis and water dew point) shall be split pro rata, depending on the Base Production and Incremental Production recorded at the Point for which the calculation is made.
- By mutual written agreement, the Parties may amend the required list of personnel for each Group so that an optimum and efficient employment of work force is ensured.
- The effective costs with the injection of residual water shall be split pro rata between Amromco and Romgaz depending on the injected water volumes resulting from the separation phase of Base Production and of Incremental Production.
