

RESOLUTION NO. 4/June 12, 2014 of the Ordinary General Meeting of Shareholders

Societatea Nationala de Gaze Naturale "ROMGAZ" - S.A.

Today, June 12, 2014, 12:00 AM (Romania time), the shareholders of Societatea Nationala de Gaze naturale "ROMGAZ" – S.A. (hereinafter referred to as "the Company" or "ROMGAZ") have joined at the Ordinary General Meeting of Shareholders ("OGMS") of "ROMGAZ" at its first convening at the headquarters of Societatea Nationala de Gaze Naturale "ROMGAZ" – S.A., located in Medias, Piata Constantin Motas 4, Sibiu county, the conference room, the OGMS being opened by its Chairman, Mrs. Aurora Negrut, as Chairman of the Board of Directors.

Whereas:

- The convening notice for the OGMS published in the Official Gazette of Romania, Part IV, no. 2507 of May 7, 2014, in "Bursa" daily newspaper of May 7, 2014 and on the company's website (<u>www.romgaz.ro</u>), starting with May 8, 2014;
- The provisions of the effective Articles of Incorporation of the Company ("Articles of Incorporation");
- The applicable legal provisions;

The Chairman notes that the OGMS is statutory and legally established and it can adopt valid resolutions regarding the items on the agenda.

In accordance with Article 129 of Law no. 31/1990, "ROMGAZ" shareholders appoint Mr. as OGMS secretaries and the Company appoints Mrs/Mr. as technical secretary of the OGMS.

I. Elect Mrs./Mr. as director of Societatea Nationala de Gaze Naturale "ROMGAZ" – SA Medias, with a mandate ending on May 14, 2017.

 - (3) One site on a location belonging to Medias Branch, total surface of 228.00 m^2 .
